It took me nearly two years after my first false arrest to identify the dark force behind this living nightmare. Once I became aware, the damage had been done. How a Son Behaved So Despicably

The moment I witnessed firsthand the son's telephone conversation with his mother, identifying his financial control and her tears of frustration, I was compelled to protect her right to spend her money and live life how she chooses.

My overwhelming instinct to care was undeniable. I developed close emotional feelings for this mother during my role as a carer for her late partner in 2016. It was impossible for me to walk away from it. I instinctively realised something was drastically wrong with her son, wanting to restrict his mum from enjoying her life, preventing her from purchasing a new TV or whatever she desired, such as sun-seeking with holidays abroad she could afford and living a quality of retired life. This son said, "It's unnecessary." Witnessing anyone having to beg is hard, but begging her son for her own investment funds to be placed in her current bank account was heartbreaking. Forcing his own mother to feel obliged to explain how her recently deceased partner's funeral bills had wiped out a large chunk of her money was most stressful and unfair. I'm sure if a bank manager behaved in such a harsh manner as her son did, it would be considered crossing the professional line. At that point, she realised her suspicions were justified. It was beyond any doubt she was being manipulated, dictated to, and financially controlled by this bossy son's decisions. His firm NO! was disturbing and overpowering, reducing his mother to tears.

Turning immediately towards me after placing the telephone down, it was apparent she was in desperation, frightened, and trapped. This kind, gentle, independent mother was made to feel inadequate and powerless. At a loss, hopelessly bullied, isolated, and alone with no idea what to do, she suddenly asked what I would do in this situation.

At this point, I also had no idea about this son's groomed employer plans. I was unknowingly treading on thin ice about to expose a well-established criminal business network targeting vulnerable people's wealth, assisted by the abuse of the court process. I shall expand on this, explaining in further detail later, confirming just how well-organised and ruthlessly calculated the abuse of hidden state power really is.

My own personal life had experienced family harshness. Perhaps that's where my strong instinct came from, having been made to feel like a failure and inadequate. Seeing those signs developing in front of me, I was full of empathy. My compassion was positively strong, and my moral compass was intact. Maybe because my caring emotions and values for doing what is right and decent were close to my heart, this controlling behaviour felt cruel, completely wrong, and repulsive to me.

I was emotionally committed and out of my depth, needing more qualifications to advise professionally. However, as a friend and as a witness, I was able to comment on what I would do in her position. The trust between us was fully established because my role as a caregiver for her late partner, albeit briefly, did shine through. It was at his dying bedside when he kissed my hand. After I reassured him I would look after his excellent partner, confirming he had now passed me the baton, he could let go now and not worry anymore.

It was later that the strong bond between us began to grow. A bent solicitor arrived at her home to discuss the late partner's will and, in my earshot, stated that his will could be altered. A variation to the will could be applied to ensure his wishes and feelings could be changed.

I was horrified to discover this could happen against the deceased's last instructions. I made my views known, excusing my intervention but at the same time making the beneficiary aware that such a change was, in fact, immoral.

No changes were made to his will, but this distanced and weakened my trust in that solicitor. It raised a red flag concern in the back of my mind: maybe he reports to the son and his toxic family friend in the shadows, possibly pulling this solicitor's strings. I discovered my fears were right.

It became apparent why this solicitor became the home property trustee. This property trust was originally her former husband's idea for tax purposes. When he died, this trust should have been cancelled. However, that option was never offered, preventing the property deeds from being made in her sole name due to the son's hidden agenda, assisted by the family's toxic friend. Codicils were wrongfully arranged, deceitfully following and reporting to this cunning son.

Now, recognising all this controlling behaviour was not just unfair; it was frightening. I agreed to act as a Lasting Power of Attorney (LPA) for both Financial and Well-Being, just in case anything did happen in the future and his mother was unable to make a decision. With me closely by her side, I could ensure her wishes and feelings for a quality of life continued. Thinking that would put a line under being controlled by the family, and his mother would be left free to enjoy her retirement plans rightfully. I had just added fuel to the fire without even knowing it. Talk about being considered public enemy number one. I became a prime state target, but I never saw it coming.

After the LPA had been approved by the accountant acting as the certificate provider for the donor and the Office of the Public Guardian had officially registered that documentation, that crooked firm of solicitors was informed. They organised for the local GP to confirm their mental capacity, arranged a meeting, and produced attendance notes to write this fraudulent son out of his mother's estate. The cost to do this was exploitation at its best, ten times the cost of producing a new will to remove one son.

This massive unjustified cost led to a change of solicitors, who produced a brand new will cost-effectively, taking everything into account. During the changing of legal firms, we discovered the second set of property deeds, a two-bed apartment with a garage. Then the penny dropped. Things began to make sense: why were these deeds kept unregistered for years under this firm of solicitors, and why was trust in the home never a consideration? Because that crooked firm was acting for the fraudulent son in his best interests, not his mother's.

Indeed, looking after themselves quite nicely.

Their web of corruption and deceit soon overcame us in the financial profession, which, as of today, thrives in the hands of these criminals who dominate our legal profession and court system.

I also discovered, to our horror, that behind this son was his employer, who encouraged their employees' conflicts of interest with family and friends. What I didn't realise at the time was just how well-established the

company was with the Court of Protection as another extremely lucrative business referral scheme. It's just that this scheme is protected by the undue influence they had over public officers and officials. I soon found out the hard way just how much state control they really had, and as you will read, it isn't very comforting.

I intend to explain the nitty-gritty facts behind why placing profit before people justifies labelling this ruthless greed as despicable. When investment companies abuse their trust and integrity, the darker side of the industry is a force like no other. Their ability to intimidate and coerce their employees into performing disturbing, unscrupulous dealings with family funds, and in this case, abusing the court of protection process through a network of compromised judges, spills over into the crown court.

As the months passed, the betrayal of his mother's trust became painfully clear. She had always believed her son was managing her finances with her best interests at heart. However, the reality was far different and far more sinister. During a routine visit to her bank, she made a shocking discovery: her accounts were almost empty.
